

GAZEBO RENTALS




As the weather warms up, the Watergate Gazebos provide a beautiful space for residents and their guests to spend time outdoors within VA state COVID safety guidelines. There are two easy ways to use these Gazebos:

- 1. Reserve a gazebo via the Activities Office. There is a \$100 Rental Fee for a single gazebo; \$150 for the double gazebo.
- 2. Contact Patrol Services beginning at 9 a.m. on the day you want to use a gazebo. If one has not been reserved by that time, the gazebo may be used free of charge.

Residents may not use the gazebo spaces without prior authorization from the Activities Office or Patrol Services. All residents using the gazebos must complete check-in paperwork before setting up and complete check-out paperwork before leaving the gazebo area after use!

PUT YOUR "SELFIE" ON FILE



Photos, once on file, have many benefits for WAL

residents. Below are a few reasons why you should opt to registering a current photo on file.

The most common benefit is to issue WAL Resident ID cards so residents can enjoy many of the wonderful amenities WAL has to offer (pool, Racquet Club, Shuttle Bus, etc.). Unfortunately, without an ID or photo on file, access to these amenities and other items may be denied.

One benefit most residents do not think of is connected to community/building access. For instance, when a resident is locked out of his/her building/unit or tries to enter the community via taxi, Uber, Lyft, etc., a photo on file confirms identity and WAL Residency to the Patrol Services Officer on duty should the resident not be able to present a WAL ID at the gate. Unfortunately, this happens very often.

Another benefit is community security. Sometimes, people claim to be official residents. They may be a guest or someone related to a resident who may or may not be listed as frequent visitors in FSR, however. Having photos on file will eliminate any inconveniences to residents while simultaneously providing a barrier against unauthorized property access.
