Include your name, building and unit number in your response. Also note whether you want to speak during the residents forum and the topic of discussion in your reply. We will then email you the conference phone number and access code. For those who sign up to speak, a code will be provided that allows you to un-mute your phone. The Board President will call your name and you will have three minutes to speak. Thereafter, you will need to mute your phone for the remainder of the meeting.

## WHERE'S YOUR BIKE DECAL?

Residents, be sure to obtain current registration decals for all bicycles stored in the garage racks or parking spaces if you did not do so at re-registration. Bicycles must have a yellow decal that states, "EXP. Jan 31, 2021."



As per Association Bylaws, unidentified bicycles on WAL property will be removed, stored for 30 days and then disposed of as necessary. Patrol Services Officers are currently culling racks and issuing a one-time courtesy notice on bikes that have expired or missing decals. Be sure to protect your bike by obtaining an up-to-date bicycle decal at the Resident Services Office!



## PLEASE USE THE FAN WHILE COOKING

Make sure your kitchen fan works properly. Every time you cook, be sure to turn it on! This helps funnel the air to the proper outside areas rather than into the hallways or other units. Thank you!

## POOL USE DURING COVID-19



Don't forget to bring your current WAL ID with the gold "expires Jan. 31, 2021" affixed each time you come to the pool. Also, keep the following in mind when visiting the pool facilities here at WAL:

### OUTDOOR POOL

- Entire pool is open for diving, exercise, free swim or instruction.
- Only three people are permitted in diving area with 10-foot distancing.
- The outdoor spa, foot wash river and the spray pad are closed.
- Pool (not deck) must close every 45 minutes for disinfection of touch surfaces.
- There is a maximum of 250 residents total in both outdoor pool areas whether the persons are in the pool or not.
- While within this facility maintain 10 foot of physical distance between anyone who is not from the same household.
- **Face coverings are recommended when not able to maintain social distancing.**
- There is a three person maximum per lane with 10-foot distancing between swimmers in the outdoor lap lane.

### INDOOR POOL

- Entire pool is open.
- Spa and saunas are closed.
- Pool (not deck) must close every 45 minutes for disinfection of touch surfaces.
- No more than 62 residents can be in the facility whether they are in the pool or not.
- While within this facility maintain 10 foot of physical distance between anyone who is not from the same household.
- **Face coverings are recommended when not able to maintain social distancing.**
- There is a three person maximum per lane with 10-foot distancing between swimmers in the indoor lap lane.

Many Alexandria residents have called AHD with complaints about people not wearing face covers or crowding into elevators in residential buildings. In a letter published on July 14, the AHD Health Director made this clarifying statement:

“Executive Order 63 does apply to indoor common areas of apartment or condominium buildings. This may include lobby areas, mailrooms, laundry facilities, and elevators.”

As a result, it is mandatory that all residents wear masks while using indoor public spaces at WAL for any purpose. Please be sure you’re following the law and refrain from confronting persons not wearing a mask personally or directly.
